



SCREENING ROUND

- THE PARTICIPANTS NEED TO SUBMIT A BRIEF SUMMARY OF THEIR CASE WITH DIAGNOSIS (ABSTRACT) BY MAIL (abstract must be submitted at: respirare25.casecraft@gmail.com) IN MS WORD/ PDF FORMAT BY 14TH AUGUST AND THE SELECTED PARTICIPANTS WILL BE INFORMED SHORTLY.
- THE TITLE SHOULD BE IN WRITTEN IN CAPITALS AND THE TEXT IN TIMES NEW ROMAN.
- ABSTRACT WORD LIMIT- 600 WORDS.
- ABSTRACT MUST INCLUDE THE FOLLOWING HEADINGS: TOPIC, AUTHOR, GUIDE, COLLEGE, INTRODUCTION TO TOPIC, CASE PRESENTATION AND CONCLUSION.
- THE CASE SHOULD CONSTITUTE RELEVANT POSITIVE AND NEGATIVE FINDINGS IN THE HISTORY, VITAL PARAMETERS ON PRESENTATION, GENERAL AND SYSTEMIC EXAMINATION FINDINGS, LABORATORY AND OTHER SPECIAL INVESTIGATIONS, DIFFERENTIAL DIAGNOSIS PROPOSED, FINAL DIAGNOSIS PROPOSED, SURGICAL/THERAPEUTIC INTERVENTIONS MADE AND THEIR OUTCOME, CONCLUDED BY A FINAL SUMMARY OF ALL OF THE ABOVE.
- TO AID IN EXPLANATION THE PHOTOGRAPHS OF THE PATIENT CAN BE USED BUT THE PATIENT'S IDENTITY SHOULD NOT BE REVEALED.

FINAL ROUND

- THE CASE SHOULD BE BACKED BY A POWERPOINT PRESENTATION IN LANDSCAPE/PORTRAIT FORM.
- TIME LIMIT: 6 MINUTES
- AFTER THE PRESENTATION THERE WOULD BE A 3 MINUTE QUESTION ANSWER SESSION BY THE JUDGES. PRIZE POOL IS SUBJECT TO CHANGE.
