

RULES AND REGULATIONS

- TEAMS SHOULD COMPRISE A MINIMUM OF 4 MEMBERS AND A MAXIMUM OF 12 MEMBERS
- MAXIMUM 6 SPEAKERS
- ANY FORM OF PLAGIARISM WILL NOT BE PERMITTED

ABSTRACT

- MAXIMUM WORD LIMIT FOR ABSTRACT: 800 WORDS
- SHOULD INCLUDE: INTRODUCTION, AIMS, OBJECTIVES, METHODOLOGY, RESULTS, CONCLUSION
- THE TOPIC OF THE PRESENTATION SHOULD BE MEDICALLY RELEVANT WHICH CAN BE BASED ON ANY OF THE FOLLOWING: CLINICAL, PARACLINICAL, LABORATORY OR COMMUNITY AND ALLIED SUBJECT.
- STRICTLY ADHERE TO THE FORMAT AND WORD LIMIT.
- NO DISCREPANCY BETWEEN THE ABSTRACT AND THE FINAL PRESENTATION SHALL BE SEEN ON THE FINAL DAY.

TIME

- PRESENTATION TIME: 20 MINUTES PER TEAM
- System check: IO minutes per team
- QUESTION AND ANSWER ROUND: 5 MINUTES
- MARKS SHALL BE REDUCED FOR EXCEEDING TIME LIMIT
- THE COLLEGE IDENTITY SHOULD NOT BE REVEALED DURING THE PRESENTATION OR SPEECHES

CRITERIA FOR EVALUATION

- CHOICE OF TOPIC (NEITHER TOO NICHE NOR TOO BROAD)
- INDIVIDUAL PERFORMANCES
- NOVEL TEACHING METHODS

PRESENTATION FORMAT
